## **Freedom of Information Act Request**

I am writing in response to your e-mail of the 21<sup>st</sup> July 2024. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

## Requested information:

I would like to request the number of occupied bed days (excluding leaves) for each Mental Health ward and their costs per year since 2015 or the earliest recorded year in the system, as well as the current number of people under the care of the Trust or last known population number.

## Please see Appendix 1 attached.

We are unable to provide costings earlier than 2019/20. Going any further back would be using an inconsistent costing methodology to recent years. The figures provided are direct and indirect costs for the wards according to our Service Line Reporting (SLR) model.

14,406 people were under the care of North Staffordshire Combined Healthcare NHS Trust as at 31/03/2024.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review of the management of your request.
