## Requested information:

- 1. Does your NHS Trust provide its employees (doctors, nurses, other clinical staff) with Occupational Health (OH) Services? **Yes**
- 2. If yes, what has been your annual spend on Occupational Health (OH) services for your employees over the last 3 years (FY 2021/22, 2022/23, 2023/24)?
  - 2021/22 £86,771
  - 2022/23 £129,686
  - 2023/24 £101,162
- 3. Please split the annual spending between physical occupational health services and mental occupational health services for the last 3 years (FY 2021/22, 2022/23, 2023/24). There is no split between physical and mental health. Staff are seen based on their need.
- 4. Does the Trust provide these services in-house, or does it outsource it through a contract? **Occupational Health contract is outsourced** 
  - Please provide the split of the percentage of in-house vs outsourced services based on the values provided in Question 2 (i.e., how much is spent on OH services in-house vs contracting to outsourced providers) for the last 3 years (FY 2021/22, 2022/23, 2023/24)? Occupational Health Services is 100% Outsourced for the last 3 years
