I am writing in response to your e-mail of the 15th October 2024. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

I am conducting some research on waitlist validation and data linkage in the NHS. I am particularly interested in the different techniques and solutions used for these purposes. I was hoping you'd be able to answer the following question under the Freedom of Information Act:

1. How is waitlist validation carried out in your Trusts? Please select one of the following options: Manually / Semi-automated / Automated.
 - a. If your response was semi-automated or automated, which tools do you use?
Please specify the types of tools or software used.
2. How many FTEs currently work on waitlist validation and what band are they? Please specify the number per band.
3. How has your FTE count working on waitlist validation increased in the past 2-3 years? Please provide an estimate if you do not have the exact number.
4. In the past 12 months, approximately how long has the waitlist validation process taken? Please provide an estimate if you do not have the exact number.
5. What data quality issues have been identified the most frequently as part of the waitlist validation process? Please select those that apply from the list below:
 - a. Decision to admit but no waiting list entry
 - b. Missing waiting list or pathway information (e.g. due date, intended procedure)
 - c. Patients on an admitted waiting list without an active RTT (Referral to Treatment Pathway) clock
 - d. Past TCI (To Come In) dates
 - e. Potential duplicates
 - f. Other - please specify

We have interpreted the questions above to be aimed at Acute Trusts who have national Referral to Treatment (RTT) measures. As we are a Mental Health Trust we believe that these questions not applicable to North Staffordshire Combined Healthcare NHS Trust.
