Freedom of Information Act Request

I am writing in response to your e-mail of the 5th July 2023. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

1. Request Details:
 - Please provide information on the Learning and Development (L&D) budgets within your NHS Trust, specifically focusing on the allocation of funds to different departments.
 - **Trust training budget – available for all**
 - **CPD budget – qualified staff only**
 - **Psychology budget – Psychology staff only**
 - I kindly request details regarding the L&D budget accessible to middle managers, including the process or criteria for their eligibility.
Middle managers can access any of the three budgets. Process for criteria is through the training needs analysis which is completely on a year-on-year basis and is an opportunity for staff to request paid training that's been identified at the annual appraisal. Confirmation of funding highly depends on what the budget allocation is each year.
 - Additionally, I am interested in understanding how your Trust determines which L&D programs or initiatives to invest in.
The central training budget is firstly top sliced for any strategic bids. The remaining amount is then divided by headcount and award to each directorate the senior leads to agree on how the funding is spread within each directorate
 - Information on central training budget allocation broken down by workforce, e.g., medical, nursing, allied health professional, admin, and management.
