Freedom of Information Act Request

I am writing in response to your e-mail of the 24th July 2023. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

1. Does your Trust have a sustainability working group/board?

The Trust has a Greener Working Group which is attended by Sustainability Champions and representatives from different professional groups, who work across different services and directorates. This working group is led and facilitated by the Transformation Management Office (TMO). The Trust also has a Trust wide Sustainability Group, who meet monthly, which is chaired by the Chief Strategy Officer

2. If your Trust does have sustainability working group(s), how many are there and what do they focus on?

There are 2 groups.

The Greener Working Group essentially focus is on high level updates / brief highlight reports (by exception) from respective leads / representatives on different areas of focus as set out in the Staffordshire and Stoke-on-Trent Integrated Care System (SSOT ICS) Green Plan. The group met to share ideas, use as "thinking space" and make key decisions to take to the Sustainability Group.

Within the North Staffordshire Combined Healthcare (NSCHT) Sustainability Group, the focus is on Action Plan updates, Regional Updates, Presentation of updated Green and Sustainability Dashboard by the TMO, Communications Update and Any Other Business. Going forward, the submission of Quadrant Highlight reports for each Area of Focus, against deliverables, has been proposed.

3. If your Trust does have sustainability working group(s), how many people in total attend meetings for this group (from the last three meetings)?





17th May 2023 = 7 attendees 21st June 2023 = 10 attendees 19th July 2023 = 12 attendees

4. If your Trust does have sustainability working group(s), how many clinicians in total attend meetings for this group (from the last three meetings)?
