Contract Data/API Contact Details

 Can you also provide me with contact details of the person responsible for the actual contract's register or someone responsible for API? [Name, Job Title, Telephone, Email Address] At the very least provide me with their actual job title.

(Meaning of API "a set of functions and procedures that allow the creation of applications which access the features or data of an operating system, application, or other service.")

Freedom of Information Act Request

I am writing in response to your e-mail of the 15th September 2023. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

I have requested an average spend for each supplier annually, not an accurate breakdown of spend down to per module/licence etc. I believe that the Organisation should release this information, as I think the commercial sensitivity is reduced due to it not being a complete breakdown of the services. I feel that the information I have requested is not necessarily sensitive and does not outweigh the public interest. If this information still cannot be released, please submit an internal review.

The exemption (S43) applied for the redacted costings is qualified under the Public Interest Test (PIT). The Trust cannot reveal the values as the contract value, years of cover, and description would give sufficient information to pinpoint the exact cost and thus provide competitors with a benchmark to beat competitive tendering, which would breach Public Contract Regulations (PCR) 2015.
