Freedom of Information Act Request

I am writing in response to your e-mail of the 26th September 2023. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

- 1. A list of the OFF-framework agencies used by the trust in the past 12 months. **Thornbury Nursing Services**
- 2. The average length of time a long-term agency placement is left vacant before being filled by the agencies who are ON framework in the past 12 months. Unfortunately, this information is not held in an easily accessible format and not easily obtained without individually checking each shift and its lead time. We believe that the cost of collating the information to respond to your request would exceed the threshold of £450 as defined by the Freedom of Information and Data Protection (Appropriate limit Fees) Regulations 2004. As a result, we are refusing your request under Section 12 of the Freedom of Information 2000.
- 3. How many long-term bookings and individual shifts have been placed through OFF-framework agencies in the past 12 months' (Please separate individual shifts and long-term placements? 638 filled shifts all shifts relate to one patient who has specific and exceptional needs which cannot be met from within the Trusts core staffing establishment, and they are placed with the Trust on a temporary basis.
- 4. Average cost per hour for Band 5, 6 and 7 agency workers paid to OFF-framework agencies in the past 12 months.
