1. What is the population size you cover?

The Trust serves the population of Stoke-on-Trent and North Staffordshire (Newcastle-under-Lyme and Staffordshire Moorlands) with a population size of 477,525. (2021 census). We do however have services with wider catchment areas that serve patients across our ICS and West Midlands.

- 2. What proportion of your contracted budget is spent on Mental Health (if unknown, please provide an estimate) For 2022/23 it's 51.3%
- 3. Please complete the table below for the last 5 financial years starting with the financial year April 2018 and detail the digital funding you have received from NHS sources i.e., NHS England or associated commissioners (integrated care boards/clinical commissioning groups).
