Freedom of Information Act Request

I am writing in response to your e-mail of the 21st November 2023. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

I am requesting data as to staffing (WTE) per percentage of the population for Core CAMH Services across the country. I was wondering if you could assist with this please?

CAMHS Services in the Trust:

North Staffs CAMHS

This service provides secondary mental health services for Newcastle under Lyme and surround and the Staffordshire Moorlands. The service covers a catchment area population of roughly around 142,000. At any one time, the team carries a total case load of around 500 cases.

South Stoke CAMHS

The service provides secondary mental health services across the South Stoke area which includes the towns – Stoke, Fenton, Longton, Meir, Trentham, Blythe Bridge and Shelton. The service covers a catchment area of roughly 95,000 with many areas experiencing high levels of deprivation. The team carries on average of 500 cases.

North Stoke CAMHS

The service provides secondary mental health services across the North Stoke area which includes the towns such as Burslem, Abbey Hulton, Tunstall, Birches Head and more. The service covers a catchment area of roughly 83,000. At any one time, the team carries a total caseload on average of 500 cases.
