Freedom of Information Act Request

I am writing in response to your e-mail of the 12th October 2024. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

Please disclose how much (total £) the Trust has spent on on-framework agency, off-framework agency, and bank staff in the past four full financial years (2020/21; 2021/22; 2022/23; and 2023/24).

In this instance, "on-framework" refers to organisations on NHS England's list of approved staffing providers. "Off-framework" refers to those who are not on this list but still provide services to trusts.

The figures should pertain to totals in each financial year and overall since 1st April 2020 (i.e., the start of the 2020/21 financial year). If possible, please also disclose:

- 1. A breakdown by total for all three (i.e., £2m on "on-framework", £800k for "offframework", £1.2m for bank) in each of the four financial years; and
- 2. If available, the top three specialties by spend in each of the four financial years (e.g., gynaecology, dermatology, cardiology).
