The purpose of the Trust is to work to improve the health and wellbeing of our local communities. <p>The Bennett Centre is located in Shelton, Stoke-on-Trent.</p> <p>Services provided at this location are:</p> <ul style="list-style-type: none"> • Autism Spectrum Disorder Assessment. The Autism Spectrum Assessment Service is a screening, assessment and diagnosis service for adults aged 18 and above. The service is for adults who do not have a learning disability but are experiencing symptoms and difficulties suggestive of an autism spectrum disorder. • Clinical Health Psychology Service. The Clinical Health Psychology Service is a specialist service within North Staffordshire Combined Mental Health Care Trust. The service offers psychological therapy for people who are experiencing mental distress as a result of a long-term physical condition, chronic pain or medically caused trauma. • Lotus Service. The Lotus service provides support for women/birthing people and their families across North Staffordshire and Stoke-on-Trent who are looking for help with their mental health which has been significantly affected by miscarriage, ectopic pregnancy, termination of pregnancy, stillbirth or neonatal death, extreme fear of childbirth (tokophobia), experiencing pregnancy and/or birth as traumatic or difficult, neonatal admission or experience of separation from your baby(ies). • Neuropsychiatry Community Service. The Neuropsychiatry Community Service delivers a spectrum of evidence-based diagnostic assessments, treatment, interventions and support to improve and maintain the mental wellbeing of people with neurological conditions who require support and treatment for psychiatric, psychological, cognitive and behavioural problems arising from their condition. • Neuropsychology. The Clinical Neuropsychology service works with individuals from 18 years old and above. Our team comprises consultant clinical neuropsychologists, clinical neuropsychologists, clinical psychologists and assistant psychologists working across inpatient wards and outpatient clinics. • Paediatric Psychology Service. The service provides a specialist psychological service to children and young people aged 0 to 18 years old and their parents and families where there are psychological issues. • Parent and Baby Service. The Parent and Baby Service is a specialist perinatal secondary mental health service. The service is interested in the prevention, detection and management of perinatal problems that complicate pregnancy and the postpartum year.

Blurton Health Centre is based in Blurton, Stoke-on-Trent. The following service is based at this location: <ul style="list-style-type: none"> CAMHS South Stoke. The CAMHS (child and adolescent mental health services) South Stoke Team supports the emotional wellbeing and mental health of children and young people. The team works with children and young people up to the age of 18 years old who are experiencing significant difficulties with their emotional wellbeing/mental health, or where there are concerns regarding their development which could be seen as consistent with a neuro-developmental disorder such as Autistic Spectrum Disorder (ASD) or Attention Deficit Hyperactivity Disorder (ADHD). ADHD assessments can be carried out for children over 6 years of age. The service offers assessments to understand a child/young person's difficulties and, where appropriate, deliver specialist interventions guided by evidence-based practice and guidelines.

The CAMHS (child and adolescent mental health services) Autism Spectrum Disorder (ASD) Team provides an assessment only ASD service to the children and young people across Stoke-on-Trent and North Staffordshire. Assessments and diagnosis are for those aged 0 to 18. • Specialist Children's Short breaks. The Specialist Children's Short Breaks Service provides overnight short breaks for children and young people aged 4 to 19 years old with severe learning disabilities and other complex needs such as complex health, physical disabilities and behaviours that challenge. The team consists of a mixture of registered learning disability nurses and Healthcare Support Workers all with great knowledge, training and experience. 	

- Paediatric Psychology - The Paediatric Psychology Team provides a specialist psychological service to children and young people aged 0 to 18 years old and their parents and families where there are psychological issues related to acute or chronic physical illness or traumatic injury.
- Keyworking Team. The team provides a high quality, navigational service for children, young people (0-25 years) and families with a Learning Disabilities and/or Autism Spectrum Condition (ASC). Working as a key member of the multi-disciplinary team and in an integrated way with wider teams across Staffordshire and Stoke-on-Trent, to meet the needs of our CYP and families/carers.
- Mental Health Support Team. Mental Health Support Teams (MHSTs) are for children and young people in primary, secondary and further education (ages 5 to 18) and the education settings in which they learn. The team has staff who are trained to deliver evidence-based low-level interventions (CBT informed) that are delivered to children and young people who are experiencing mild to moderate mental health issues – these are called Education Mental Health Practitioners/Children's Wellbeing practitioners.
- Youth Offending Team. The Staffordshire Youth Offending Service works across the youth justice system as part of a wider team of staff from social, health, education, housing, police, probation, and drugs and alcohol misuse services. This multi-disciplinary team works together to find out the specific problems that make a young person offend and measure the risk that they pose to themselves and others. The team supports young people aged 10 to 18 years old on a one-to-one basis, or in partnership with other services in the area, and can give someone further therapeutic support if this is needed.

- Liaison and Diversion Team. The Liaison and Diversion Team is a specialist service commissioned via NHS England. Those in contact with the criminal justice system are far more likely to have unmet health and social care needs and vulnerabilities. The team offers specialist multi-vulnerability assessment from the point of arrest to the point of sentence. This enables key decision makers to have sufficient information about an individual's needs in order to make informed decisions. The team also ensures that referrals to services to meet unmet needs are made and proactively supports engagement. The service operates out of police custody and the magistrates court as well as having a community follow-up pathway to provide an assertive engagement approach.
- Staffordshire and Stoke-on-Trent Talking Therapies. The service provides evidence-based talking therapies and self-help courses for people with common mental health difficulties such as anxiety and depression who can be treated in primary care. The service has an Employment Advisor Service that provides help related to gaining, returning or staying in work who may be receiving a talking therapy in the service. It is available to people aged 16 years old and above with no upper age limit who live in Stoke-on-Trent or North Staffordshire or who are registered with a Stoke-on-Trent or North Staffordshire GP.
- Ascend Recovery Service. Staffordshire and Stoke-on-Trent Ascend Recovery Service is based at Lancaster House, 25 Iron Market, Newcastle-under-Lyme ST5 1RH and provides training, consultation, staff support and evidence-based psychological services for people aged 16 and above who have experienced sexual assault or abuse. The service works in partnership with Staffordshire Women's Aid and Savana and aims to bridge the gap between primary and secondary NHS services. Our team consists of a clinical psychologist, CBT therapists, mental health practitioners, an education trainer, a research assistant, assistant psychologists, peer support workers, and a team administrator. We currently take referrals from staff within existing NHS services (such as talking therapies) and our VCSE sector partner agencies (Savana and Staffordshire Women's Aid).
