- 2. For each of the above persons who works or has worked at your Trust, please confirm:
 - i. Whether the complaint(s) is/ are based on allegations of antisemitism or islamophobia and/ or racism towards Palestinians and/ or Arabs. **Antisemitism**
 - ii. The name of any organisation that submitted the complaint. Individual
 - iii. Whether the complaint arises from the person's actions at work and/or outside work. **Work**
 - iv. Whether the complaint is being or has been dealt with under informal or formal disciplinary procedures. **Informal**
 - v. The content of the complaint (deleting any personally identifiable information). **Data not available**
- vi. The outcome of any disciplinary hearing. N/A
