## **Freedom of Information Act Request**

I am writing in response to your e-mail of the 23<sup>rd</sup> May 2025. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

## Requested information:

- 1) How much was spent on secure mental health patient transfers by private ambulances in the 6 months to 31st March 2025? £98k
- 2) How many journeys were made on secure mental health patient transfers by private ambulances in the 6 months to 31<sup>st</sup> March 2025? **Approximately 60.**
- 3) Please provide a list of all private ambulance companies used for secure mental health patient transfers in the 6 months to 31<sup>st</sup> March 2025 and for each detail: Main provide is Exclusive Secure Transport
  - a) Number of jobs. Approximately 60.
  - b) Cost of providing the service by role (RMN, HCA hourly rates).
  - c) Cost per mile charge.
  - d) Service / admin charge.

The Trust has considered this part of the request as exempt under section 43 (2) as release of the information is likely to prejudice the commercial interests of any person (A person may be an individual, a company, the public authority itself or any other legal entity).
