Freedom of Information Act Request

I am writing in response to your e-mail of the 2nd July 2025. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

Under the Freedom of Information Act 2000, I am writing to request a vehicle fleet list operated by the Trust, whether owned or leased. I would appreciate it if you could provide the following details for each vehicle:

- Chassis Make and Model.
- Registration Mark of each motor vehicle (VRM).
- Date of acquisition.
- Date of disposal (if applicable) for vehicles decommissioned between 2020 and 2025.

Please see Appendix 1 attached.

Please note Chassis data not available.

The Trust is not releasing the full registration numbers of the Trust's vehicles under Section 38(1)(b) – Health and Safety. All information released under Freedom of Information is deemed to be in the public domain. As a Mental Health Trust the full registration numbers could potentially be used for purposes that would place not just the Trust's property at risk but also members of staff could be targeted. We consider there are a number of possible security or fraud risks with releasing this information.

I would be grateful if this information could be provided in an accessible format such as Excel, Word, PDF, or text.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review of the management of your request. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to: Dr Buki Adeyemo, Chief Executive, North Staffordshire Combined Healthcare Trust, Trust Headquarters, Lawton House, Bellringer Road, Trentham, ST4 8HH. If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
