Freedom of Information Act Request

I am writing in response to your e-mail of the 18th September 2025. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

I'm writing to request some information under the Freedom of Information Act 2000 regarding the vehicles currently in use by North Staffordshire Combined Healthcare NHS Trust. This includes any vehicles that are owned, leased, or otherwise provided for the Trust's operations.

For each vehicle, please provide the following information:

- Make and model.
- Body colour.
- Date of first registration with the DVLA.
- Date of the next MOT (where applicable I am aware that vehicles under three years old are exempt from MOT testing).

I would also be grateful if you could confirm whether the Trust itself holds the V5C registration documents for these vehicles, or whether these are retained by a leasing company or another third party.

The information requested relates only to basic vehicle details and statutory roadworthiness requirements. It does not include registration marks or any personal data and should therefore be straightforward to disclose.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review of the management of your request. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to: Dr Buki Adeyemo, Chief Executive, North Staffordshire Combined Healthcare Trust, Trust Headquarters, Lawton House, Bellringer Road, Trentham, ST4 8HH. If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
