- c. How many incidents of inpatient self-harm involving plastic bin liners have there been in the last five years (specifically 2020, 2021, 2022, 2023 & 2024)? **0**
- d. How many inpatient deaths involving plastic bin liners have there been in the last five years (specifically 2020, 2021, 2022, 2023 & 2024)? **0**

- a. Are other types of plastic bags (i.e. not bin liners) allowed into psychiatric inpatient wards run by your Trust? **Yes, on an individual risk assessed basis.**
