I am writing in response to your e-mail of the 25th March 2025. Your request has been processed using the Trust's procedures for the disclosure of information under the Freedom of Information Act (2000).

Requested information:

In accordance with the Freedom of Information Act, please could you answer the following questions -

- Who holds trust wide responsibility for the maintenance of procedures and policies? What is their name and email address? **Nicola Griffiths, Deputy Director of Governance.**
Staff email addresses are exempt as they constitute personal data and would contravene the principles of the Data Protection Act 2018 (in accordance with qualified exemption S40 (2)(a) of the FOI Act).
- What digital tools does the trust use for the staff to reference these procedures and policies? - i.e. – intranet. **The Intranet - Combined Access Tool (CAT).**
- How does the Trust record that staff have read and comply with the procedures and policies? **The Trust does not record that all staff read and comply with procedures and policies.**
- Which tools are used for on-boarding new staff in relation to reading procedures and policies? **Corporate Induction.**
- How do the heads of department monitor that clinical and non-clinical staff have read/understood mandatory procedural updates? **There is a Policy Governance Group and Policy Leads attend this Group and share information regarding updated/ new policies which is disseminated to teams. We also have a Senior Leadership Team that receives all policies for review/ update/ consultation and Committees receive for final approval.**
